## **GENERAL LAWS OF MASSACHUSETTS**

### **CHAPTER 148. FIRE PREVENTION**

#### **Chapter 148: Section 10A Heads of fire departments; permits; inspections; records; fees; list of fire department heads**

Section 10A. The head of the fire department in each city, town or fire district shall grant, in accordance with the rules and regulations of the board, such permits for use in such city, town or fire district as may be required by such rules and regulations, and make such inspections therein, and have and exercise such powers and duties in connection therewith, as the marshal may direct. The head of the fire department shall keep a record of every permit so issued, and shall furnish the marshal with such information in respect to such permits as he may require. A fee of \$25, unless otherwise set in a town by the board of selectmen or town council, and in a city by the mayor, may be charged by the head of the fire department for any permit granted under authority of this section, and any such permit may be revoked for cause by him or by the marshal, but in no event shall any such fee be greater than \$50.
